The Cherry Creek School District requires families to update their household information each year including emergency contacts, medical, child demographics, and policy acceptance forms. The on-line parent forms system is accessed as follows:

You must have the following information available to create a parent account:

Please understand that this is a District mandated process. Students will NOT receive a schedule unless the on-line parent forms have been successfully completed.

Any student who has not been admitted to the Cherry Creek School District will not have access to the on-line system. Please be sure to verify your student's enrollment at the Admissions Office if you are new or have moved.

IMMUNIZATION INFORMATION!

Several changes have been made to student immunization requirements. The Cherry Creek School District Office will provide families with this new information as soon as it becomes available this summer. Please check our website regularly for updated information.

- ◆ Adolescents are required by law to receive their Tdap immunization prior to entry into 6th grade. In addition, two doses of Varicella are now required for all K-12 grade students. Immunization records may be sent or delivered to Falcon Creek to the attention of the school nurse.
- ◆ Parents exempting their student from immunizations must sign a new exempt form each year. The Cherry Creek School District will provide you with details regarding this process.

IMPORTANT INFORMATION IF YOU MOVE. . .

- If you are moving within the Falcon Creek attendance area, you are still required to change your address at the Cherry Creek School District Admissions Office.
- If you are moving out of Falcon Creek's attendance area, but within the Cherry Creek School District attendance area, you will be required to change your address with the Cherry Creek Admissions Office and complete an **Intra-District Transfer Application** (approved by the principal), if you wish to keep your child at Falcon Creek.
- If you have moved out of the Cherry Creek attendance area, a **Non-Resident Application** is required (also approved by the principal).
